Subject: Extension of promotional scheme under Voice only facility on FTTH – reg.

Kindly refer Circular R&C-CFA No. 43/12-13 dated 14-10-2013, wherein the approval of Competent Authority was conveyed to continue/extend voice only facility on FTTH by revising the condition of minimum FMC commitment and to offer any landline plan of Rs. 180/- and above on promotional basis for 90 days, subject to some conditions.

2. In view of the good response, the competent authority has decided to extend the above scheme (as launched vide R&C-CFA circular no. 43/12-13 dated 14-10-2013) for "Voice only facility" on FTTH by offering any landline plan of Rs. 180/- & above, for further 90 days on promotional basis in all the circles.
3. All other terms and conditions, as mentioned in circular no. 43/12-13 dated 14-10-2013 and clarification issued vide circular no. 52/12-13 dated 28-10-2013, shall remain unchanged.
