**Circular R&C-CFA No.193/16-17**

**Subject: Introduction of promotional scheme to waive off installation charges for new FTTH connections in all the Circles -reg.**

1. In order to increase FTTH connection base, to utilize spare FTTH capacity and to achieve the FTTH connection targets during FY 2016-17, the Competent Authority has decided ***"to introduce promotional scheme for a period upto 31-03-2017 to waive off installation charges for the new FTTH connections (voice/Broadband/combo) in all the circles."***
2. ***The circles shall ensure to comply with all regulatory mechanism.***
3. All other terms and conditions shall remain same as per earlier circulars.
4. These instructions shall **be effective w.e.f. 23-01-2017 on promotional basis for a period upto 31-03-2017 in all the Circles.**
