1. CGM, UP (West) Telecom Circle, may kindly refer his office letters vide No. UPW/BB-566/Tariff/2015-16/57 dated 19-12-2016, seeking approval for extension of Broadband plan 'BBG Combo ULD 499 CS156', 'BBG Combo ULD 599 CS157' & 'BBG Combo ULD 749 CS158' and FTTH plans 'Fibro Combo ULD 999 CS38' & 'Fibro Combo ULD 1249 CS39' in Ghaziabad & Noida SSA of UP (West) circle only.
