Subject: Re-launch of promotional scheme under “Voice only facility” on FTTH in Tamilnadu circle only – reg.

1. CGMT Tamilnadu Circle may kindly refer to his office proposal letter no. MKTG/CFA/FTTH/Tariff-Corr/13-14 dated 29-05-2014 seeking approval for extension of promotional offer of “Voice only Facility” on FTTH with minimum FMC of Rs. 180/-
2. The proposal has been examined in this office and **the Competent Authority has decided to re-launch the scheme (as launched vide R&C-CFA circular no. 43/12-13 dated 14-10-2013) for “Voice only facility” on FTTH by offering any landline plan of Rs. 180/- & above, for a period of 90 days on promotional basis in the Tamilnadu circle only.**
3. All other terms and conditions, as mentioned in circular no. 43/12-13 dated 14-10-2013 and clarification issued vide circular no. 52/12-13 dated 28-10-2013, shall remain unchanged.
4. These instruction shall be effective **w.e.f. 13-06-2014 in Tamilnadu Circle on promotional basis for 90 days.**
