Subject: Restoration of the PAN India Broadband plans '5GB plan', '10GB plan', '15GB plan' & '20GB plan' and withdrawal of certain Circle Specific Broadband/LL plans in MP Telecom Circle-reg.

1. CGMT MP Circle may kindly refer to his office proposal vide letter No. CGMT/CFA/Mktg/03-02/ECT Minutes/12-13/CH-I/61 dated 15-01-2019, seeking approval for introduction/review/withdrawal of Landline/Broadband (DSL/FTTH) plans in MP Circle.

2. The proposal has been examined by the tariff committee and following has been decided by the Competent Authority:

a) **To restore the PAN India Broadband plans '5GB plan', '10GB plan', '15GB plan' & '20GB plan' on regular basis for all the existing as well as new customers in MP Telecom Circle.**

b) **To withdraw following add-on voice packs in MP Circle:**

c) **To withdrawn Circle specific Broadband/LL plans for new customers in MP Circle.**

Existing customers under above LL/BB plans shall continue. However, efforts may be made to migrate these customers to some other DSL/FTTH Broadband plans.

3. **Since all the DSL BB plans are available on FTTH with same tariff, the above plans shall also be available on FTTH with same tariff.**

4. The Circle shall ensure to comply with all regulatory mechanism **including on line reporting to TRAI and also update the Circle Website.**

5. The above instructions shall be **effective w.e.f. 01-02-2019 on regular basis in MP Circle only.**

6. All other terms and conditions shall remain unchanged.


