Subject: Revision of Installation Charges in respect of FTTH services - reg

1. Kindly refer to the letter vide No. 111-05/2012-BP-Ent dated 30-04-2012 wherein tariffs of FTTH services were reformulated.
2. **Now, Competent Authority has decided to revise the Installation charges in respect of FTTH services as follows:-**

Facility	Existing Installation Charges (in Rs.) on FTTH	Revised Installation Charges (in Rs.) on FTTH
NPC with only Broadband service	500/-	750/-
NPC with only Voice service	500/-	750/-
NPC with Combo plan having voice and broadband	500/-	750/- + 250/-*
Provisioning of Broadband service over the existing voice service	NIL	250/-*

* If ONT is taken on rent from BSNL or ONT is purchased by the customer from outside and installation by BSNL

3. **The circles shall ensure to comply with all regulatory mechanism.**
4. **All other terms and conditions shall remain same as per earlier circulars.**
5. The above instructions **shall be effective w.e.f. 20-06-2016 in all the circles.**
6. This circular is issued based on the approval of Competent Authority in Broadband Cell File No. 64-370/2015-16/BB/Tariff/Pt.1.
