Subject: Revision under circle specific FTTH Broadband plans 'Fibro Combo ULD 1499 CS29' & 'Fibro Combo ULD 2490 CS36' and introduction of add-on voice packs for offering 24 hrs. Unlimited free calls (Local + STD) to any network under broadband combo plans in Odisha circle - reg.

- CGMT, Odisha circle may kindly refer to his office proposal vide letter no. CFA-OR/PMSM-004/2017-18/73 dated 23-11-2017 seeking approval for revision under FTTH Broadband plans and introduction of add-on voice packs for offering 24 hrs. Unlimited free calls (Local + STD) to any network under broadband combo plans in Odisha circle.
- The proposal has been examined by the tariff committee and following has been decided by the competent authority:
 - To revise FTTH Broadband plans 'Fibro Combo ULD 1499 CS29' & 'Fibro Combo ULD 2490 CS36' in Odisha telecom circle only , for all the existing as well as new BB customers as follows:-**


B. Add-on voice packs for offering 24 hrs. Unlimited free calls (Local + STD) to any network under DSL/FTTH broadband combo plans with FMC Rs. 600/- & above, in Odisha telecom circle on regular basis.

Details are as follows:-

- Add-on Voice pack of Rs. 48/- per month – for making 24 hrs. unlimited calls to any network within circle.**
 - Add-on Voice pack of Rs. 98/- per month – for making 24 hrs. unlimited (local + STD) calls to any network in India.**
 - The above add-on voice packs shall be available only to the Broadband users for “retail use” having Broadband combo plan with plan FMC Rs. 600/- & above.**
 - The “retail use” is defined as follows:-**
 - Outgoing calls should be less than 300 unique numbers in a month**
 - If the customer availing add-on voice packs as above, has not fulfilled the retail use condition as per para (d) above, add-on voice pack shall not be applicable and the customer will be charged as per existing broadband plan tariff. In this regard, applicability of ‘add-on’ pack will be checked on monthly basis.**
 - The customer should be educated properly for the retail use condition as above and an undertaking to this effect shall be taken from the customers availing add-on voice packs.**
 - The above add-on voice packs shall be available in Odisha telecom circle on regular basis.**
 - The circles should ensure that above add-on voice packs are offered to Broadband users for retail use in those SSAs/cities/locations/colonies of Odisha telecom circle, where there is similar offering from other operators.**
- All other terms and conditions shall remain same as per the earlier circulars.
 - The circle shall ensure to comply with all regulatory mechanism including on line reporting to TRAI and also update the circle website.
 - These instructions shall **be effective w.e.f. 07-12-2017 in Odisha Telecom circle only.**
