Subject: Voice only facility on FTTH – reg.

Kindly refer BP-Enterprise unit circular no. 111-05/2012-BP-Ent dated 30-04-2012, vide which under para 2.3, it is mentioned that “any combination of current tariff plans of landline voice, BB and IPTV, including the BB combo plans, may be allowed to the subscriber subject to the total minimum FMC commitment of Rs. 499/- and above.”.

2. In order to promote the FTTH services, the Competent Authority has decided to allow voice only facility on FTTH. Accordingly, the approval of Competent Authority is hereby conveyed to allow FTTH subscriber to choose any existing landline voice plan subject to the minimum FMC commitment of Rs. 499/- or above.
3. All other terms and conditions, as mentioned in earlier circulars, shall remain unchanged.
4. These instructions shall **have immediate effect in all the Circles.**
5. This circular is issued based on the approval of Competent Authority in Broadband Cell File No. 64-03/2009-BB/. **Clarification/correspondence, if any, in respect of above tariff may be sent to Broadband Section, BSNL, Corporate Office, Janpath, New Delhi-110001, Tel.
