Circular R&C-CFA No. 43/12-13

Subject: Voice only facility on FTTH – reg.

Kindly refer Circular R&C-CFA No. 03/13-14 dated 03-04-2013, wherein “the approval of Competent Authority was conveyed to allow voice only facility on FTTH & FTTH subscriber to choose any existing landline voice plan subject to the minimum FMC commitment of Rs. 499/- or above”.

2. Above has been reviewed & in order to promote the FTTH services, **the Competent Authority has decided to continue/extend voice only facility on FTTH. The condition of minimum FMC commitment of Rs. 499/- has been reviewed & now any landline plan of Rs. 180/- and above may be offered on promotional basis for 90 days, subject to following conditions:-**
 - a. Such customers shall not be more than 20% of the total FTTH capacity in the city.
 - b. ***Such FTTH connections shall be provided at the places where ever telecom services are not feasible on copper network.***
3. All other terms and conditions, as mentioned in earlier circulars, shall remain unchanged.
4. These instructions shall **be effective with immediate effect in all the circles.**
5. This circular is issued based on the approval of Competent Authority in Broadband Cell File No. 64-218/2012/FTTH Tariff. **Clarification/correspondence, if any, in respect of above tariff may be sent to Broadband Section, BSNL, Corporate Office, Janpath, New Delhi-110001, Tel. No. 011-23322064 and Fax No. 011-23734052.**
