**Subject: Introduction of scheme for waiver of FTTH Installation charges, Security deposit of ONT and security deposit for Landline on the FTTH Broadband connections provided by 'Local MSO/LCO operators & TIPs/RWAs/Builder' in AP and Telangana Circles - reg.**

1. CGMT Telangana Telecom Circle may kindly refer to his office proposal letter No. TT/CS-I/BB FTTH/Promotional Offers/2016-17/06 dated 21-03-2017 seeking approval for introduction of promotional offers in AP and Telangana Circles.
2. The proposal has been examined in this office and the Competent Authority has decided **to introduce following scheme on regular basis to the new FTTH Broadband connections provided through 'Local MSO/LCO operators & TIPs/RWAs/Builders' (who are providing their own OLT & ONT and installing/maintaining the FTTH Broadband connection) in AP and Telangana Circle only:**
  - a) **To waive off Landline and Broadband Installation Charges for the FTTH Broadband connection.**
  - b) **To waive off FTTH ONT Security Deposit.**
  - c) **To waive of Landline Security deposit charges under FTTH Broadband connection.**
3. **The circle should ensure to comply with all regulatory mechanism and also update the circle website.**
4. All other terms and conditions shall remain unchanged.
5. These instructions shall **be effective w.e.f. 04-04-2017 on regular basis in AP & Telangana Circle.**
6. This circular is issued based on the approval of Competent Authority in Broadband cell file No. 64-402/2016-17/BB/Tariff.
