



**Circular R&C-CFA No.72/18-19**

**Subject: Waival off FTTH ONT rental charges under Broadband plans in Chennai TD -reg.**

1. CGM, Chennai TD may kindly refer to his office proposal vide letter no. GM (S&M) CFA/Free ONT/2018-19 dated 20-06-2018 seeking approval for rent free ONT for annual payment FTTH customers.
2. The proposal has been examined by the tariff committee and the Competent Authority has decided ***"to waive of monthly rental charges of Rs. 90/- for FTTH ONT (when ONT is taken on rent from BSNL) only to the existing Broadband customers who opted Broadband plan (i.e. Standalone/Broadband only/Combo) with FMC of Rs. 699/- & above under annual/higher payment option in Chennai TD."***
3. ***The circle shall ensure that the above instruction shall be applicable to non WiFi FTTH ONTs only.***
4. ***The Circle should ensure to comply with all regulatory mechanism including online reporting to TRAI and also update the Circle website.***
5. The above instructions shall be **effective with immediate effect on regular basis in Chennai TD only.**
6. **All other terms and conditions shall remain the same.**
