Subject:-Rebate of additional 300 MCUs on promotional basis for a period of 90 days to the subscribers who arrange their own telephone instrument at the time of provision of new telephone connection.

It has been observed that due to shortage of telephone instruments, field units are facing difficulty in providing new telephone connections.

Therefore, Competent Authority has decided to offer additional 300 free calls in addition to normal free calls to the prospective customers who arrange their own telephone instrument at the time of provision of new telephone connection. Accordingly, the approval of Competent Authority is hereby conveyed as follows:-

- i. Customer who arranges his own telephone instrument for provision of a new telephone connection shall be allowed 300 MCUs free over & above the free MCUs available to the plan opted for by the subscriber. These free MCUs will be distributed equally in three billing cycles @ 100 MCUs per billing cycle and shall be applicable from 2nd billing cycle.
- ii. The telephone instrument so arranged by customer under this scheme shall not be replaced by BSNL in the event of its becoming faulty. To avoid misuse of this scheme, the change of faulty telephone instrument (s) provided by BSNL should only be with the issue of OB.
- iii. CGMs of all territorial circles are authorized to implement the scheme in their Circles, based on non-availability of telephone instruments.
- iv. The above concession will be in addition to the existing rebate in installation charges.
- v. The scheme shall be on offer for a period of 90 days or till there is a shortage of telephone instruments in the Circle whichever is earlier.
- vi. The scheme shall have immediate effect.
- vii. This circular is issued based on the approval of Competent Authority in NWO-CFA File No.25-02/2011/ NWO-CFA / IN. For any clarification/correspondence, in this regard, matter may be taken up with (NWO-CFA) branch of BSNL CO (Tel No. 011-23714148 Fax-011-23734366).
