- 2. On the change in international carrier charges of Austria, Croatia, Finland, Micronesia, Netherland, Poland & UK, the competent authority has approved revision of ISD tariff for the above mentioned destination. The ISD tariff for (i) plan wise with 60 sec pulse duration, (ii) for plans working on MCU basis, and (iii) ISD PCOs as given below.
