

**Circular R&C-CFA No. 105/17-18**

**Sub: - Revision of Tariff for “Virtual” Landline connections under Plan “ASEEM”-Regarding.**

1. The Competent Authority on recommendation of Tariff Committee-CFA has approved revision of tariff for “Virtual” Landline connections under plan ‘ASEEM’ on PAN India basis. The details are as follows:
  - (i) Call diversion from “Virtual” landline number to any one BSNL number of subscriber’s choice @ Rs.99/p.a.
  - (ii) Call diversion from “Virtual” landline number to any one other network’s number of subscriber’s choice @ Rs.199/p.a.
  - (iii) DNP Customers for three months or more can take “Virtual” landline connection under plan “ASEEM”.
  - (iv) On shifting of residence in TNF area, existing landline customers shall be allowed to opt “ASEEM” plan.
  - (v) Voluntary closure customers are allowed to opt for “ASEEM” plan.
  - (vi) For existing customers tariff may be revised as per TRAI guidelines.
  - (vii) All other terms & conditions shall remain same.
2. The Circle should ensure to comply with all regulatory requirements.
3. The above instructions shall be **effective from 01.09.2017**.
4. The circular is issued based on approval of the competent authority in Broadband unit file No. 8-53/PDP-CFA/2013-14/Pt.2. for any clarification /correspondence in respect of aforesaid scheme, matter may be taken up with PDP-CFA unit of BSNL CO New Delhi. Phone No.011-23322064.
