Tariff Circular

Subject: Prescribed charges for customers, browsing high speed Internet and using video conferencing facilities, from BSNL STD/ISD PCOs.

STD PCOs are allowed to be converted into Multi Utility Telecom Points vide circular no. 115-21/2005-Comml Dated 02/06/2005.

2. In continuation of the same, the competent authority has approved the tariff for provision of following services to retail customers at STD/ISD PCOs as under:

2.1 Ceiling tariff for browsing at high speed Internet on BSNL Broadband for customers of STD/PCOs:

Sl.	Time Used	Maximum charges (Ceiling)
1	Upto 15 minutes	Rs.15
2	Upto 30 minutes	Rs. 25
3	Upto 60 minutes	Rs. 40

2.2 STD PCOs shall be allowed to charge market based tariff extra for allowing big downloads and printouts.

2.3 Ceiling tariff for Video Conferencing from STD PCO:

Sl.	Type of Video Conferencing (Pulse of 60 seconds)	Maximum charges (Ceiling)
1	Point to Point	Rs.20 per minute
2	Point to Multi Point(N)	Rs.15 * N per minute

3. STD PCOs may avail Broadband and Video conferencing services from BSNL at following terms and conditions,

3.1 STD PCO operator may take any business (including Startup Plan) plan on applicable tariff except Unlimited Business Plans.

- 3.2 STD PCO operator may also take any video conferencing plan on applicable tariff.
- 3.3 All the charges for having Broadband and Video Conferencing facility from BSNL shall be payable by STD/PCO operator on prevailing rates.
- 3.4 Discount on bills (Plan charges and usages) of broadband portion only should be allowed based on the revenue to STD PCOs, as under:

Monthly Billed amount exclusive of Service Tax (in Rs.)	% of discount (Non-graded basis)
Up to Rs.700	5%
Rs 701 to Rs.2000	7%
Rs.2001 to Rs.5000	9%
Above Rs.5000	12%

- 3.5 No discount shall be available on modem charges.
- 3.6 Existing agreements shall have to be suitably amended for provision of this service. A clause of indemnification is required to be included for misuse of this service from STD PCO for pornographical/ adult use or against interest of national security.
- 3.7 The above tariff is exclusive of Service Tax, which will be charged extra as applicable.
- 3.8 The above tariff will be applicable w.e.f. 1st April, 2008.
- 3.9 All other terms and conditions in respect of above services will be as per the earlier circulars shall continue to be applicable on this tariff also.
