Subject: Revision of Minimum Guarantee and tariff for call charges in respect of all type of Postpaid Landline PCOs including Fixed PCOs provided on WLL-reg.

Kind reference is invited to this office circular No. 3-5/2007-R&C dated 11.04.2008, 15.05.2008, circular No. 3-6/2009-R&C dated 26.02.2009 and circular No. 2-2/2009-R&C [CFA] dated 13.04.2010, through which the tariff for call charges and the Minimum Guarantee of all type of Postpaid landline PCOs including WLL PCOs were prescribed.

In this context the Competent Authority has decided to revise the Minimum Guarantee and tariff for call charges in respect of all type of Postpaid landline PCOs including Fixed PCOs provided on WLL. **Accordingly the approval of the Competent Authority is hereby conveyed the revised tariff structure for all types of Postpaid PCOs including Fixed PCOs provided on WLL as follows:**

A. Minimum Guarantee Amount :
