Sub: Launch of WiMAX billing through GSM B&CCS

CMTS, Nodal Center, Trichy was designated as Coordinating Center for integration of WiMAX subscribers' billing through GSM B&CCS. There were issues with regard to API details sharing raised by TCS and Bangalore NOC but all of those stand resolved last month. The work of integration is delayed too much and Director (CM), BSNL Board, desires that the billing of WIMAX subscribers in the South zone should start with effect from 1.9.2011. The migration of data in respect of existing subscribers may be managed manually as the number of subscribers, at present, is not many.
