

Promotional Offers	Proposed plan
For Govt. and PSU officers/official	Rs. 599/- + GST as one time registration charges in place of Rs. 1099/- + GST.(Other charges as per existing tariff plan)
Existing BSNL landline Customers	No charges for initial 2 Months. Thereafter, Rs. 1099/- + GST to be paid as one time registration charge.(Other charges as per existing tariff plan)
For Students (Studying) with valid ID card	20% rebate on Rs. 1099/- + GST (one time registration charge). (Other charges as per existing tariff plan)

4. **The Circle should ensure to comply with all regulatory requirements.**
5. **The above instructions are effective after three days from the date of issue of this circular i.e.24-08-2018 for a period of 90 days in all the circles.**


