It is requested that the above data may be used for ensuring the availability of CAF for all the working connections to complete the project at the earliest . Necessary arrangements may be made to make the Data Entries for the pending cases for which the Address is yet to be fed.

As per CO letter no MOB-27/CAF/2010 DATED 23-12-2010, reverification of CAF availability with PIA documents followed by scanning of CAF activity was supposed to be completed by 31.10.2010. Based on request the licensor gave one more but last extension till 31.12.2010. DOT/TERM Cell will start checking with effect from 01.01.2011 and shall recommend disconnection of connections along with imposition of penalty to the tune of Rs.50000/- per incomplete / Non Scanned CAF.Entry of CAF data in the B&CCS must happen within 72 hours as emphasized vide letter dated 24.05.2010.

Kindly bestow your personal attention for timely completion of reverification of CAF availability alongwith PIA documents followed by scanning of CAF activity..
