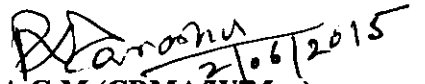

Kindly refer the TRAI letter cited under reference-1 on subject matter. TRAI has stated that full MNP (Intra+ Inter circle MNP) has to be implemented. For implementation of full MNP in CDMA Mobile network, following guideline may be followed:

- 1) For smooth testing/implementation of full mobility in CDMA N/w, circles should designate one officer as a SPOC and same should be conveyed to this office on e-mail Id mnpbsnldma@gmail.com.
- 2) For Port-in of any MSISDN level of any TSPs in CDMA Mobile network, it is required to define the GSM & CDMA MSISDN level of all TSPs in all CDMA MSCs/HLRs/WINs in the circles.
- 3) Vide letter under reference-2, DOT has amended the National Numbering plan 2003. It is required to implement this amendment by making all necessary changes in CDMA Mobile network elements, so that all mobile to mobile calls(PAN India, inter operator) can mature in all three scenarios i.e with 0, without 0 and with +91.
- 4) For IOT/AT, every LSAs are required to forward 02 nos of activated test SIM to other BSNL LSAs and to MTNL Delhi & Mumbai each. These test SIMs will be required to generate UPC in roaming scenario, so that UPC can be used to port in these test numbers in different TSPs in other circles.
Test SIM should be one prepaid and one postpaid and must be created at least 90 days old. Prepaid SIM should be created in base plan and having Rs. 50 in account. The test SIM should be shared with SPOC of concerned LSAs.
In case of LSAs comprised more than one circle, it may be ensured that test SIMs includes numbers from counterpart circles also.
- 5) Through annexure of letter under reference-3, NWO-CM cell has circulated final test matrix and annexure for IOT/AT for MNP testing. LSAs should follow the same test matrix and annexure for IOT/AT for Full MNP testing in CDMA.

- 6) Vide letter under reference-4, NWO-CM cell has issued instructions on IOT/AT test fees. Same guideline shall be also applicable for CDMA also.

All circles are requested to follow the instruction mentioned above for full MNP testing and provide weekly progress report and SPOC details to this office on mail id mnpsnldma@gmail.com.
