Circular T&C -CM No. 70/11-12

Sub: Clarification on introduction of new RUIM based prepaid plan "Parivar" and rationalization of tariff under CDMA services -req.


Kindly refer to this office order of even No. dated 29.09.2011 on the subject mentioned above. Based on technical non-feasibility reported by Nodal center in respect of new RUIM based prepaid plan "Parivar", it has been decided by the competent authority to hold the "Parivar" plan in abeyance until further orders.

2. Further, in response to queries raised by field units, the following clarifications are issued.

Queries	Clarifications
i) Whether the revised call rate is applicable to all existing as well as new STV?	i) The revised rate is applicable to customers taking the STV after the date of implementation. Existing customers who have already activated the STV will continue to enjoy the old rate till the validity of STV.
ii) Whether the Off-net call rate of 1.2p/sec in the "per sec" STV is applicable to only lifetime customer or normal & lifetime both?	ii) The "per sec" STV is applicable to both normal and lifetime customers.
iii) There are promotional offers, which are valid upto 08.10.2011 as per circular No.24-08/2009-R&C (Pt.1) dated 08.07.2011.	iii) The date of implementation of Circular T&C-CM No.66-11-12 dated 29.09.2011 is changed from 01.10.2011 to 09.10.2011.
iv) For implementation of STV for old and new customers whether circles can suitably adjust the price of STV?	iv) Yes, circles can suitably adjust the price of STV in the price band upto Rs.3 (+/-) of above price considering the local market condition and technical feasibility.

3. This may be brought to the notice of all concerned for taking necessary action in this regard.
