Sub: Integration of landline phones (residential and office) under Project Tarang.

Tax Department (ITD) is an important Enterprise customer of BSNL. BSNL could get this business with lot of efforts and ITD was assured that all the facilities to them as per MoU would be extended to them as per time schedule. By this time, all the existing landline phones of the Department installed at various offices and at the residence of officers should have been migrated into ITD Plan of Project Tarang. However, complaints are being received from M/S ITD that they are receiving bills in respect of these lines on monthly basis while as per Project Tarang, no fixed monthly charges are to be taken.

To expedite the process of transfer the landline phone in the ITD Plan, Additional Director Income tax (Nodal officer of the Project) has suggested that since the existing official landline phones either at office or residence are subscribed as per the designations mentioned below, BSNL Nodal officer should make a list after checking in BSNL Landline Billing System and should be integrated in the Project Tarang after getting vetted with the respective Chief Nodal Officer / Additional Commissioner of I Tax (HQ). In this regard, letter dated 21-04-2011 received from Addl. Director of Income Tax (Infra) New Delhi is also enclosed for reference. The various designations are:

- Income Tax officer.
- Assistant Commissioner / Asst Director of Income Tax.
- Deputy Commissioner / Deputy Director of Income Tax.
- Commissioner / Director of Income Tax.
- Chief Commissioner / Director General of Income Tax.

In any case, the total number of landline connections should not exceed the total quota allotted by ITD to that Circle. The Broadband connections are to be installed at residence only.

In case of NCR, lots of Income Tax Officers located in Delhi are having residence in NCR region (Ghaziabad, Noida in UP West Circle and Gurgaon and Faridabad in Haryana Circle). The concerned SSA Heads are hereby made the Nodal officer for such cases. They will be getting the list of all such existing or new connections from GM, MTNL for necessary action. They should carry out the same with intimation to this office.

The centralised payment has already been received by Income Tax Department in NTR, which will be apportioned to all circles / SSA. Guidelines for same is being issued by CA, BSNL CO. Kindly ensure that **No phones of Income tax Department is disconnected. In case of any clarifications, kindly consult this office.**

It shall be ensured that the migration of all existing lines is completed by 30-04-2011. The progress report is to be mailed on weekly basis at **Email ID ssundar1959@gmail.com**.
