## Circular T&C-CM No. 58/12-13

Now, in addition to above it has been decided by the Competent Authority to launch a promotional scheme of 10% and 20% discount on 3G Data plan FMC and data STVs as under:-

c) The existing STV of Rs.1500 with bundled free data of 15000MB and validity of 1 month will be withdrawn.

d) All other terms and conditions will remain same.
