## Subject Provision of free PRBT for all postpaid subscribers except CUG on eve of New Year- regarding

Approval of competent authority is hereby conveyed for provisioning of free PRBT service in all Circles for all postpaid subscribers except CUG customers on the eve of New Year i.e. 01.01.2018. The commercial and technical details of offer is here as under:

- i. BSNL will provide free PRBT subscription to all non-PRBT POST-PAID subscribers except CUG with free default signature.
- ii. There shall be following category of PRBT subscribers under the offer:
  - a. Subscriber with free PRBT subscription and free default signature and unbranded Tunes (say Cat A).
  - b. Subscriber with free PRBT subscription and chargeable (Rs 12/- per month) Premium Tunes from limited catalogue (say Cat B).
  - c. Subscriber with chargeable PRBT subscription (Rs 30 per month) and chargeable (Rs 12/- per month) Premium Tunes from full catalogue (say Cat C).

In turn PRBT vendors shall make efforts to convert such "free PRBT subscription subscriber" to "Limited catalogue Premium Song PRBT subscriber (Cat B)". Out of Rs 12.00 BSNL shall pay Rs 5+Rs 1 to PRBT vendors. Additional Re 1 is to be paid to PRBT vendors as incentive.

- v. Cat A and Cat B subscribers shall be offered a bigger catalogue of premium songs. If opted such subscriber will become Cat C subscriber (normal PRBT subscriber). Out of Rs 30.00 subscription fee BSNL shall pay Rs 5+Rs 1 to PRBT vendors. Out of Rs 12.00 song fee BSNL shall pay Rs 5+Rs 1 to PRBT vendors. Additional Re 1+1 is to be paid to PRBT vendors as incentive.
- vi. Name Tune shall be considered as Premium Song.
- vii. If new short codes etc. are required for the service the same shall be issued by BSNL free of cost.
- viii. The above offer shall also be valid for all future POST-PAID subscribers.

Following commercials shall be paid to BSNL to PRBT vendors:

- a. PRBT vendors are to be paid Re 1.10 as monthly subscription fee for this offer.
- b. If PRBT vendors converts free PRBT subscribers to Lim. Catalogue Premium Song subscribers then BSNL shall pay Rs 6 ( Rs 5 as fee and Re 1 as incentive)to PRBT vendors out of Rs 12 received from subscribers.
