Circular T&C-CM No. 26/16-17

All CGMs- Telecom Circles/ Telephone Districts

Sub: Rationalization of Postpaid plan 325, 525, 1500, Data Add-ON, Extension of “Student special” and Introduction of New Postpaid plan-1125 under postpaid/ prepaid mobile services -reg.

Kindly refer to this office letter of even no. dated 26.08.2015 and orders/clarifications issued from time to time on the subject mentioned above. Now, it has been decided by competent authority **to rationalize/ introduction of tariff under postpaid/ prepaid mobile services** as under:-

A. Rationalization of Postpaid Plan 325 and 525:

For Postpaid Plan 325 and 525, pulse rate has been modified from existing “**30 sec**” pulse to “**60 sec**” pulse subject to TRAI TTO 43rd amendment, i.e. customers who are in the plan for less than 180 days, should remain with same pulse till 180 days.

B. Rationalization of Postpaid Data Add-ons:

The following Data Add-ons has been rationalized:

5. Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
