**Sub: Rationalization of tariff under prepaid mobile services-reg.**

Kindly refer to this office letter of even no. dated 29.05.2015 and subsequent orders issued from time to time with regard to tariff under prepaid mobile services. Based on current market scenario and increase in service tax, it has been decided by competent authority to rationalize below voice STVs as under:-


- All the other terms and conditions will remain same.

- This may be brought to the notice of all concerned for taking necessary action in this Regard. Press note and proper advertisement as deemed fit may be made. Circles may also send SMS conveying the above tariff to the customers.
- Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
