**Sub: Rationalization of data tariff under prepaid mobile services-reg.**

Kindly refer to this office letter of even no. dated 09.10.2015 and subsequent orders/clarifications issued from time to time with regard to data tariff under prepaid mobile services. Now the competent authority has decided to rationalize the prepaid data STVs under mobile services, as under:-


\*If denomination is not vacant, then circle may choose a denomination between Rs. 26 to Rs. 33 excluding Denomination of Rs. 30.

- This may be brought to the notice of all concerned for taking necessary action in this Regard. Press note and proper advertisement as deemed fit may be made. Circles may also send SMS conveying the above tariff to the customers.
- Circles have to update their website and report the same to TRAI as per tariff reporting requirement of TRAI.
- This circular is issued based on the approval of ECT vide Approval No.2069 dated 24.11.2015 in P&P-CM cell file No.3-38/ECT/2015/P&P-CM(Pt.II).
