Kindly refer to this office order of even No. dated 14.11.2012 on the above subject under which the replacement charges of 2G (Normal SIM) and 3G (USIM) were revised. Now based on the feed back received from the field units, it has been decided by competent authority to modify the charges for replacement of defective/ lost SIM for 2G & 3G prepaid connection as under:-

- (A) 2G (Normal SIM)- Free with condition of the compulsory Top Up /Flexi Top -Up/ Physical of Rs. 100 (Incl. of S. Tax).
- (B) 3G (USIM) Free with condition of the compulsory Top Up /Flexi Top -Up/ Physical of Rs. 140 (Incl. of S. Tax).
- 2) All other terms and condition will remain same.
- 3. The above revision will be applicable with effect from 15.10.2013.
- 4. This may be brought to the notice of all concerned for taking necessary action in this regard.
