**Subject: Promotion of Draughtsman (Civil/ Electrical/Telecom) as  
JTO(Civil)/(Elect.) – regarding.**

The matter of treatment of Draughtsman (Civil/Elect/Telecom) cadre and gainful utilization of the existing Draughtsman have been considered in light of the agreement reached in National Council with the representative union and subsequent discussions with the representatives of the Union. Consequent upon acceptance of the recommendations given by the Committee formed for the purpose by the Competent Authority, the following instructions are hereby issued:-

- i. It has been decided to fill up 50% vacancies in JTO(Civil)/JTO(Elect.) cadres also from Draughtsman (Civil/Elect./Telecom) cadres possessing the eligibility prescribed in Para (ii) below as one time relaxation, through a Limited Internal Competitive Examination, notification for which shall be issued by the DE Branch separately.
- ii. Apart from Company employees possessing the qualification as prescribed in JTO ( C)/JTO(E) Recruitment Rules 2001 for 20% quota, all the working Draughtsmen upto 55 years of age as on 1<sup>st</sup> July 2006 and having qualification of two year Diploma/Certificate in Civil/Electrical/Mechanical Draftsmanship with minimum ten years service in Gr.'C' in the department in the corresponding stream shall also be eligible to appear in the internal competitive examination. The Draughtsmen possessing the qualification of two year Diploma/certificate in Civil Draftsmanship shall be eligible for the exam of JTO(Civil), whereas the draftsman possessing the qualification of two year Diploma/certificate in Electrical/Mechanical Draftsmanship shall be eligible for the exam of JTO(Electrical).
- iii. Syllabus and scheme of examination shall be circulated by Civil/Electrical Wing of Corporate Office separately.

- iv. After having qualified the Examination, the candidates shall have to undergo an in-service course within one year to make up the shortfall in their qualification on account of the relaxation. The candidates who fail to successfully complete the in-service course shall be liable to be reverted back to their parent Draughtsman cadre. ✓ (X)
- v. Further, the Draughtsman cadres in Civil/Electrical/Telecom Wing are declared as wasting cadres with immediate effect. Posts held by the existing incumbents shall be treated as personal to them and their posts shall stand abolished as and when vacated by the incumbents due to promotion, retirement etc.
