I) dated 24.10.2013 and letter no. 216-51/2004-O&M dated 14.02.2013 (copy enclosed), wherein it was brought to the notice of all CGMs regarding complying with the instructions of CVC issued from time to time on reference seeking 2nd stage advice of CVC.

In the matter it is again mentioned here that the consultation with the CVC envisages in two stages. The first stage of consultation arises when initiating disciplinary proceedings while the second stage consultation is required before a final decision is taken at the conclusion of the proceedings where the Disciplinary Authority a tentative opinion is at variance with the 1st stage advice rendered by CVC.

The CVC, in one of the case has observed that the disciplinary cases have been finalized without seeking 2nd stage advice of the commission even though the decision of the disciplinary authority is at variance with CVC's 1st stage advice.

Hence, the commission has advised to issue suitable instructions to all the disciplinary authorities regarding the procedure to be followed during the processing of disciplinary cases for seeking second stage CVC advice. Various instructions vide 009/VGL/056 dated 28.01.2010 along with instructions dated 16.04.2004, 03.08.2001 and 08.01.2004 has already been issued from time to time.

I shall be grateful, if these instructions are circulated to all disciplinary authorities working under your control for strict compliance under intimation to CVO BSNL.

References on the subject matter and instructions of the CVC issued from time to time are endorsed to all Vigilance Heads, BSNL for complying with the instructions on the subject matter. In this connection, please refer to this office letter no. 29-3/2010-VA/12 dated 19.03.2010 (copy available in the intranet under 'Vigilance') wherein it was stated that cases in which CVC has issued 1st stage advice in respect of the composite cases, the Disciplinary Authorities should seek second stage advice. However, a case has come to notice that Disciplinary Authority did not seek 2nd stage advice, presumable due to not knowing the mandatory procedures regarding seeking 2nd stage advice as mentioned in above referred CVC OM ..

Therefore, it is again reiterated and clarified that irrespective of level of the public servant, second stage advice should be sought in the case of all employees where the Disciplinary Authority's opinion is at variance with the 1st stage advice rendered either by CVC or CVO, BSNL. It is therefore requested that the above may be brought to the notice of all concerned Disciplinary Authorities in the Circle for adherence to the above procedure invariably.
