- (2) By the impugned order the Tribunal has directed awarding uniform grace marks to all candidates to fill-up unfilled vacancies of Junior Accounts Officer.

R.S.N.L. Rules of 2001 the question of grant of uniform grace marks cannot be considered much less grace marks directed to be given.

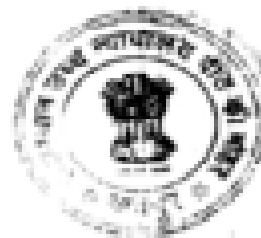
(4) The Delhi High Court set aside a similar decision passed by the Central Administrative Tribunal.
