**SUB: RECRUITMENT FOR THE POST OF “DIRECT JUNIOR ACCONTS OFFICERs (JAO)” IN BSNL FROM OPEN MARKET THROUGH ONLINE COMPETITIVE EXAMINATIONS-2017 held on 5<sup>TH</sup> & 6<sup>TH</sup> NOV 2017 — Declaration of result on revised answer keys & normalized marks thereof reg....**

I am directed to state that a Direct Recruitment examination for the post of **JUNIOR ACCONTS OFFICER (JAO)** in BSNL from open market was conducted on 05/11/2017 to 06/11/2017. The Merit List has been prepared on the basis of Circle-wise merit position, as per the choice of Circle opted during registration by the provisionally selected candidates and as per the category-wise (OC, OBC, SC, ST & PWD) for the net vacancy position/qualified candidates, available in the respective Circles.

2. On the basis of their performance in the aforesaid Examination notified on 4th Sep 2017, held on 5th & 6th November 2017 the Circle-wise merit list of provisionally selected candidates has been prepared who secured notified minimum qualifying part/paper wise normalized marks as per final answer key.

3. Circle-wise Merit List of provisionally selected candidates for appointment in the post of JAO (Annexure) is prepared as per the net vacancy intimated by the cadre controlling authority. The Merit List is forwarded for appointment in the post of JAO along with their online application forms (would be sent through URL link to Circle Co-ordinator) for further necessary action at your end. These Online application forms will form part of the dossier of the candidates.

4. The JAO is a Circle-based Cadre and the candidates would be selected against the vacancies of a particular Circle. The first posting of the candidate shall be in the urban/rural areas of the Circle for a stipulated period. BSNL has the right to post any provisionally selected candidates to any of the Circles either temporarily or on permanent basis. The decision of BSNL in this regard shall be final and binding. The service conditions, seniority etc. of selected candidates will be determined as per prevailing rules of the Company by Circles/cadre controlling authority.

5. The concerned Circles are, therefore, requested to issue offer of appointment letter to the provisionally selected candidates for the post of JAO in BSNL. In case of any non-acceptance of offer of appointment on the part of any candidate or found ineligible or otherwise for the said post during/after scrutiny or in case any candidate tenders resignation from cadre/BSNL or otherwise in any form, then the same be carried forwarded as left out vacancy under intimation to Rectt Branch BSNL CO & cadre controlling authority for replenishing the vacant position from Wait Listed candidates.

6. All candidates who have been provisionally selected may be asked to produce their original documents relating to the following for verification in accordance with the Advertisement/Notification issued for the aforesaid Direct Recruitment examination, as per the existing norms/guidelines :-

- i) Educational Qualifications
- ii) Age
- iii) Medical Fitness Certificate
- iv) Category Certificate in respect of OBC/SC/ST candidates
- v) Medical Certificate in respect of PWD candidates
- vi) Discharge Certificate in respect of Ex-Serviceman candidates
- vii) Misc, if any.

7. The document verification of Merit List candidates as per norms shall be completed within 30 days. The tentative date for sending for induction training would be within 10(ten days) of document verification. If any candidate is found to have registered for multiple circles to deceive, during verification or later, then his/her candidature shall be suo-moto rejected and no representation in this regard shall be entertained. The merit list of qualified candidates shall be for one year from the date of declaration of this merit list.

10. Response sheet link will be made available within 03(three) days on website [www.externalexam.bsnl.co.in](http://www.externalexam.bsnl.co.in). The data of candidates shall be uploaded in ERP/SAP module and further action to be taken by the circles along with ERP/SAP core Team accordingly
11. BSNL C.O. reserves the right to cancel/modify the aforesaid list in case of any candidate whose name might have been figured in the said list mistakenly/inadvertently at any time whenever such factor is noticed/detected.
