



Sub: Request for filling up STS (CAO) vacancies of MT Quota reg.....

In reference to aforesaid context vide Letter no. 2-1/2016-SEA BSNL dated 18.10.2018, it has been requested to recruit STS (CAO)s under 50% MT Quota of STS(CAO) as per BSNL MT RRs 2009.

In this regard it is to intimate that details provided vide above referred letter for initiation of recruitment process in aforesaid cadre of MT, do not project all essential details. It is therefore requested to provide a few essential pre-requisites as under:

i. Vacancy detail:

The vacancy detail in the light of prevailing norms specifying category-wise detail for both Int. & Ext candidates to avoid all litigations:

ii. Details of scheme & syllabus:

The MTRR-2013 along with scheme & syllabus, depicting distribution of marks, number of questions, details of negative marking, if any, with all required chapters in detail.

iii. Qualifying Criterion:

- The category-wise qualifying criterion and minimum cut-off marks of merit list, if any. (For all assessment process, category wise & section wise).
- As per the understanding of Rectt. Branch, it is a Direct exam (not LICE), wherein Internal Candidates are also allowed to apply; hence criterion should be same for both Int. & Ext. candidates (for both in terms of qualifying criterion & reservation policy). Please clarify.
- Further, whether an internal candidate, working in higher grade & pay scale, having eligibility, would be allowed or not; if allowed, then status of Pay protection thereof. Please clarify.

iv. Details regarding

Bond & : Format and amount of Bond for both int. & ext. category thereof;
Probation period : Is it Inclusive or exclusive of training period in both int. & ext. category; Clarification regarding the same is required please.

v. RR:

In this regard it is intimated that RR-2013 is in use for MT(Telecom Operation). Hence, please provide a copy latest RRs for 50% MT Quota of STS(CAO). Are all candidates supposed to undergo WT+GD+Interview etc as in MTs; it appears that if one lac candidates register, then all would have to be called for GD+Interview; which is impractical. Please clarify.


v. Approval:

vii. Any other relevant details.

The sought details are required to have an optimum standard of examination to avoid pre & post exam contradiction/discrepancy.
