

**ORDER**

DoT vide their order No. 1-4/2013-PSA (Pt.I) dated 15<sup>th</sup> January, 2015 taking reference of the powers conferred under Article 111 of the Memorandum of Association & Articles of Association of Bharat Sanchar Nigam Limited (BSNL), have conveyed the approval of the Competent Authority to appoint **Shri Anupam Shrivastava**, Director (Consumer Mobility), Bharat Sanchar Nigam Limited (BSNL) as **Chairman & Managing Director, BSNL** in scale of pay of Rs. 80,000-1,25,000/- (IDA) scale for a period of five years from the date of his assumption of the charge of the post, or till the date of his superannuation, or until further orders, whichever is the earliest subject to the following conditions:-

- i) Shri Anupam Shrivastava's performance will be closely monitored for one year;
  - ii) Confirmation/non-confirmation of Shri Anupam Shrivastava as CMD, BSNL shall be taken up after a review of his performance immediately at the end of one year of his tenure in accordance with the guidelines of PESB;
  - iii) The appointment shall be subject to review in case of a confirmed proposal for merger of BSNL and MTNL to ensure that a cohesive board be put in place for effecting the decision of merger.
2. The detailed terms and conditions of appointment of Shri Shrivastava as CMD, BSNL will be governed as per DPE guidelines on the subject and are being issued separately.
