I am directed to refer to notice dated 4-2-2022 regarding the ongoing Hunger Fast Strike started from 21-2-2022 and the various demands stated there in.

- 2. In this regard, various Appeals vide dt 7-12-2021, 29-12-2021 and 16-2-2022 have been issued to withdraw the agitation. It is also a fact that Dy CLC(C) has already requested to your office bearers to withdraw the Hunger Fast Strike during first conciliation meeting held on 4-3-2022.
- 3. It is reiterated that the Management is sincerely making efforts to resolve the issues in the best manner. Recently, worthy CMD BSNL and Director HR have held a meeting with recognized unions/association and support association on 26-4-2022 wherein worthy CMD BSNL apprised in detail about the 4G rollout and the roadmap for BSNL's revival through various projects in pipeline. It was also apprised in the meeting that the procurement process for items of transmission network, backbone network and battery/power plant has already been initiated to strengthen the network and make it more reliable.
- 4. The organisation is on a growth trajectory and a joint effort by the employees and the management is the need of the hour. In this background, our prime responsibility is to maintain services and for this cooperation of every one at this juncture is crucial in the interest of the Company.



Notice had given for agitation programs on 30.11.2021 vide letter under reference 1 above demanding: i) Promotion to the BSNL Executives through the BSNL Board approved Time Bound Promotion Policy w.e.f. 01.07.2018 onwards, which is framed as per the Terms and Conditions for Absorption in BSNL by following Reservation Policy of Govt, ij) standard Pay Scale of E2 and E3 from 01.01.2007, iii) Regular DGM promotion instead of Looking After promotion by relaxing the qualifying service, iv) Scrapping of MT and DR DGM RRs, v) Regular promotion instead of LA/ Adhoc promotions etc.

Due to Covid 19 restrictions imposed at New Delhi, the Indefinite Hunger Fast at BSNL HQs is postponed from 17.01.2022 to 07.02.2022 onwards. Quitting of Official What's App Groups and Work According to Rule will be continued.
