Dear CGMs

Kindly refer to my earlier letter of even number dated 10th March, 2022 wherein I had drawn your attention towards settlement of BSNL Superannuation Pension Scheme (SPS) cases and had requested for sending the SPS claims to BSNL CO latest by 31st march, 2022. A circle-wise list of employees, who are eligible for SPS benefits, was also circulated vide letter of even no. dated 16th February, 2022.

On review the progress of the SPS cases, it has been noted that there has not been any improvement in the matter and this office has received very few cases from circles/units till date. A circle-wise list showing the status of cases received and pending is enclosed. It is found that out of 2553 cases only 84 claim forms have been received. 28 circles/units have not submitted even a single claim form.

I would once again emphasize that the retired employees or their nominees/beneficiaries are deprived of their due benefits due to non-receipt of their claim forms and it is incumbent upon all of us to facilitate receipt of due benefits to them. I, therefore, once again impress upon all of you to give utmost priority to this issue and request you to personally monitor the progress of SPS claims. In this regard you may also entrust GM (HR) of the circle office to coordinate with Welfare Officers of the BAs and ensure that the claim form from all eligible employees or their nominees/beneficiaries are obtained and the same are sent to circle office where they are to be scrutinized by Circle nodal officer for SPS claims who forward it to BSNL CO with necessary information/documents for settlement of claims. If it is felt necessary, finance personnel may also be involved in processing of claim forms.

I shall be grateful if this issue is given special attention and claim forms are sent to BSNL CO latest by 13th May, 2022. Any further delay in submission of SPS claims will be viewed seriously and GM's (HR) will be asked to come to BSNL Corporate office personally and to explain the poor progress.
