In modification of this Department's O.M. of even No. dated 03.07.2014, the rate of DA payable to the executives and non-unionized supervisors of CPSEs (2007 pay revision) is as follows:

(a) **Date from which payable:** 01.10.2014

(b) **Average AICPI (2001=100) for the quarter June'2014 -August' 2014**

(c) **Link Point:** 126.33 (as on 01.01.2007)

(d) **Increase over link point:** 124 (250.33 minus 126.33)

(e) **Revised DA Rate w.e.f. 01.10.2014:** 98.1% [(124 ÷ 126.33) x 100]

2. The above rate of DA i.e. 98.1% would be applicable in the case of IDA employees who have been allowed revised pay scales (2007) as per DPE O.M. dated 26.11.2008, 09.02.2009 & 02.04.2009.

3. All administrative Ministries/ Departments of the Government of India are requested to bring the foregoing to the notice of the CPSEs under their administrative control for necessary action at their end.


