The leave, if any requested by the executive(s), under transfer, should not be granted under any circumstances by the Circle(s) where they are working presently without prior permission of the CO BSNL. The executive can apply for leave to the Competent Authority at the new place of posting, who will sanction the same if it is justified in the normal course.
- 4. The Circle IFAs concerned may intimate the station of posting of the executive (s) within 07 (seven) days from the date of issuance of this order. In case, station of posting is not received, then executive (s) may be relieved with the directions to report to concerned Circle. The Circle IFA(s) are requested to relieve the executive(s) under transfer iwithin 15 days without waiting for joining of substitutes in their places and TA/TP may be regulated as per the guidelines issued by BSNL vide letter No: 19-27/2002-L&A (Part) dated 15.04.2004, OM No.412-10/2009 Pers I dated 09.05.2012.
