- 3. In case, station of posting is not received, then Executive (s) may be relieved with the directions to report to concerned Circle office. Further, the circles are advised to relieve the Executive/s posted in https://executive.org/ posted in hard/ soft tenure stations only on completion of his/her prescribed Hard/ soft tenure stay period including excess leave period, as per rules/instructions.
- 5. The Circle IFA(s) are requested to relieve the Executive(s) under transfer without waiting for joining of substitutes in their places.
