Constitution of Surplus Staff Establishment (SSE) - Redeployment of Surplus Staff - regarding.

Through OM No. A-11013/31/2008-Abs.Cell cated 22^{nc} September, 2011, Group 'A' Officers of Indian P&T Accounts & Finance (IP&TA&FS) were asked to exercise their option for abscrption in BSNL/MTNL or to continue in the Government service. Officers who have retired since 1st October, 2000 could also exercise their option. Last date for exercising option for officers working in the Department of Telecommunications (DoT) and Department of Posts (DoF) or on deputation to organizations other than BSNL/MTNL was prescribed as 28th October, 2011. Such date for officers on deemed deputation to BSNL/MTNL was prescribed as 8th November, 2011.

- An O.M. dated 3rd November, 2011 was also issued whereby Group 'A' officers working on deerned deputation in BSNL/MTNL who have either not exercised their option or have opted for Government service or have exercised conditional option by the last date prescribed for exercising option i.e. 8th November, 2011, were desired to report to Dof (SrDDG, TEC) immediately after having been relieved formally by BSNL/MTNL, as the case may be, as they stand reverted to Government. It was also mentioned that officers in whose cases the courts have granted interim stay or given interim directions would not revert to Government till fin a ization of these cases.
- 3. Some IP&TA&FS officers have given their options for absorption in BSNL/MTNL. Action to consider issue of allocation order (Presidential Order) in respect of these officers has been initially the Finance (Establishment & Budget) Wing of the DoT.
- As per Rule 37-A (6) of CCS (Pension) Rules, 1972, IP&TA&FS Officers who have opted for Government service and are identified to be in excess of the requirement of the DoT and DoF are to be referred and got redeployed through the Surplus Cell of the Government in the Department of Personnel & Training (DoP&T). As on date, prade-wise break-up of total number of sanctioned Group 'A' posts of IP&TA&FS for Deptt. of Telecom (DoT) and Deptt. of Posts (DoP) is tabulated below:-

These are total posts sanctioned till date for Deptt. of Teleccia and Department of Posts. Any further sanction of the IP&TA&FS posts would be subject to the provisions of Ministry of Finance (Deptt. of Expenditure) OM No. 7(1)/E.Coord./2:011 dated 11th July, 2011 and only with the approval of Ministry of Finance/Cabinet.

In order to undertake the exercise as mentioned in paragraph 4 above, it has been decided to constitute a Surplus Staff Establishment (SSE) under Deputy Director General (FEB), DoT with immediate effect. The said Surplus Staff Establishment, having such number of officers and staff as is considered adequate and essential by DDG (FEB) out of the officers and staff presently working under him, will take expeditious action in accordance with Department of Personnel & Training OM No. 1/18/33-CS-III dated 1st April, 1989, OM No. 1/1/2002-CS.III dated 26th March 2002, OM No. 25013/6/2001-Estt.A dated 28th February, 2002 and Central Civil Services (Redeployment of Surplus Staff) Rules, 1990 and will unrictly adhere to the time lines, if any, prescribed for various activities as are envisaged of it. Besides, the said Surplus Staff Establishment will submit a progress report on weekly basis to the Joint Secretary (T), Deptt. of Telecommunications so that Secretary (T) could be apprised of the progress.
