Subject: LICE to the post of JTO (T) scheduled for 02.06.2013–reg .


An OA was filed in CAT Allahabad by TTA's(Ex-servicemen) to allow them to appear in the LICE proposed to be held on 02.06.2013 but the Hon'ble CAT Allahabad did not give the interim relief sought by the applicants (CAT Order 02.04.2013). Applicants then approached High Court Allahabad for the same relief which by its order dated 21.05.2013 gave direction to CAT Allahabad that " We therefore modify order of Tribunal dated 02.04.2013 to the extent , that where the Tribunal has held that ' no case of interim relief is made out' the Tribunal may consider tomorrow itself the claim of the petitioners no.1 to 6 for appearing in the examination for the post of Junior Telecom Officer to be held on 02.06.2013 ,but the result of the petitioners No. 1 to 6 shall not be declared and shall be subject to final outcome of the OA."

Considering the same Hon'ble CAT Allahabad in its order dated 22.05.2013 gave the same direction, that "Having heard counsel for parties, we hereby direct the respondents to accept the candidature of the applicants for the proposed examination held on 02.06.2013.However,it is provided that result of the applicant shall not be declared and shall be subject to outcome of this OA."

One of the members of SNATTA filed a case on behalf of Sanchar Nigam Association of Telecom Technical Assistants in the Principal Bench CAT New Delhi for the same relief, and Principal Bench has given the following order.

" In view of the directions given by the Hon'ble High Court of Judicature at Allahabad, we direct the respondents to allow the applicants in this O.A. 1734/2013 (MA No.1473/2013) to appear in the examination to be held on 02.06.2013 but their results shall not be declared and shall be subject to the final outcome of present O.A."

The order of the Principal Bench CAT is enclosed for taking necessary action to allow provisionally the members of SNATTA to appear in the proposed LICE.

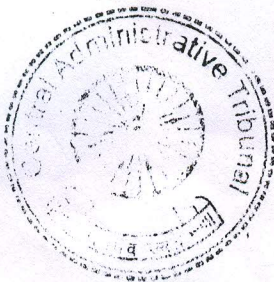
