**OFFICE MEMORANDUM**

**Subject: Fixation of pay on promotion to the new HAG scale in cases where the officers opt to have their pay fixed under FR 22(1)(a)(1) - clarification regarding.**

Consequent upon the replacement of the pre-revised S-30 Scale (Rs.22400-24500) by the new HAG scale of Rs.67000-79000, clarifications have been sought from this Department regarding fixation of pay on promotion to the new HAG scale in cases where the officers opted to have their pay fixed under FR 22(1)(a)(1) i.e. from the date of next increment.

2. The matter has been considered in this Department. In this context, it is clarified that in cases of promotion to the HAG scale of Rs.67000-79000, if a Government servant opts to have his pay fixed under FR 22(1)(a)(1), on the date of the promotion his pay will be fixed by adding an amount of Rs.2000 to his basic pay. Further re-fixation will be done on the date of the next increment of the Government servant concerned i.e. 1<sup>st</sup> of July. On that day, he will be granted two increments; one annual increment and the second on account of promotion. While computing these two increments, the basic pay prior to date of promotion shall be taken into account.
