Sub: Grant of Headquarter Allowance to the Executive employees (including un-absorbed officers who are working in BSNL on deputation/deemed deputation) on revised pay.

Now it has been decided with the approval of the Board of Directors of BSNL that Headquarter Allowance may continue to be paid at the existing rates as per Department of Personnel & Training OM No2/8/97-Estt(Pay.II) dated 16-07-1998 to the **Executive employees** (including un-absorbed officers who are working in BSNL on deputation/deemed deputation) and therefore, following revised scales are indicated as replacement against the pre-revised CDA/IDA scales for making payment of Headquarter Allowance:
