**Sub: Direct Recruitment of TTA now (Junior Engineer) for the RY-2015 ----  
Guidelines regarding maintaining waiting list of successful candidates.**

Kind attention is invited to this office letter of even No. dated 9.5.2016 vide which approval has been conveyed for filling up TTA (now Junior Engineer) vacancies through Direct Recruitment for the RY-2015 from open market. In Para-3 of the said letter dated 9.5.2016, instructions regarding maintaining waiting list as per provisions contained in BSNL CO letter No. 250-18/2006-Pers-III (Part-2) dated 21.10.2008 is hereby withdrawn in view of the fact that the instant Direct Recruitment of TTA (now Junior Engineer) is being conducted **On-Line** for the first time in a centralized manner by the Rectt. Branch of BSNL Corporate Office, New Delhi. **The waiting list of successful candidates for each Recruiting Circle shall be maintained by the Rectt. Branch of BSNL CO.**

Approval of the Competent Authority is hereby conveyed for maintaining a waiting list of the qualified candidates of DR-TTA Examination for the Recruitment Year-2015 on the following terms and conditions:-


- (i) The Rectt. Branch of BSNL CO shall maintain two lists i.e, merit list and waiting list for each Circle.
- (ii) Waiting list will consist of all those candidates who have qualified the examination but do not find a place in the merit list of successful candidates.
- (iii) Waiting list shall remain valid for a period of one year from the date of declaration of result or the date of notifying the DR Examination for the next recruitment year, whichever is earlier.
- (iv) The list of successful candidates and the waiting list shall be shown in the websites by the Rectt. Branch of BSNL CO.
- (v) Rectt. Branch of BSNL CO shall clearly indicate that the appearance of a candidate's name in the waiting list does not confer any right on the candidate for claiming appointment in the Company.

- (vi) Such selected candidates should be clearly advised to send their willingness to take up the assignment as Junior Engineer in BSNL within 30 days of the issue of the offer letter and produce an undertaking that he/she is ready to serve any where in that Circle. The notice for cancellation of candidature of successful candidate, in the event of their not turning up for training/joining as JE, may be issued under receipt, through registered post/speed post giving 15 more days time before operating the waiting list.
- (vii) In the event of drop out/non-availability of successful candidates who have been sent offer letter for appointment as Junior Engineer, the waiting list may be operated to fill up only the unfilled notified vacancies arising out of dropouts of successful candidates strictly in the order of merit in the waiting list, while canceling candidature of earlier successful candidate.
- (viii) These guidelines will apply for the DR-TTA (now Junior Engineer) for the Recruitment Year 2015 which is likely to be conducted.
- (ix) The first posting of the candidate shall be at the rural area of the Circle for the minimum period of 5 (Five) Years.

Rectt. Branch of BSNL CO, New Delhi is requested to make all out efforts to ensure that the maintenance of the Waiting list is transparent and foolproof from all angles.
