Subject:- Promotion from JTO(T) to SDE(T) against 67% seniority-cum-fitness quota for vacancy years 2008-09 and backlog vacancy cases—regarding unassessed/not assessed cases/VC pending/withheld cases

Please refer to this office letter no. of even dated 11.03.2013 through which a list of the JTOs who were left un assessed for the promotion to SDE(T) cadre for the vacancy year 2008-09 and of backlog vacancies was circulated for furnishing the vigilance status after the stay vacated by the court on this promotion process.

These cases were submitted to DPC for consideration. Accordingly DPC has assessed these cases on the basis of information's furnished so far by the respective circles. The annexure showing DPC recommendations for further inputs required to assess these cases are enclosed as per the details as under.

- 1. Annexure-A, shows the names of JTOs which are not absorbed in BSNL till date and of those against whom disciplinary case is going on/adverse entry/below bench mark cases etc. It has been directed by DPC to get the latest status on the cases and if settled then circles are requested to forward the ACRs (2002-03 to 2007-08) and the current VC of the eligible JTOs.
- 2. Annexure-B, shows the names of JTOs who are not traceable as no information's have so far been received from the circles despite being issued so many reminders. DPC has directed to put these cases on net as "Missing cases" and circles are requested to endorse these names to all the SSAs under their jurisdiction as a last chance to have access to the individual executive. After this activity if no information's are received then the names of these missing cases will be deleted from the eligible JTOs list for promotion.
- 3. Annexure-C, shows the names of JTOs who are eligible to be assessed by the DPC. Circles are requested to forward their current VC status and the ACRs (2002-03 to 2007-08) if not forwarded earlier.
- 4. Annexure-D, shows the names of JTOs who were assessed as "FIT SEALED COVER" in the DPC held in 2011. Circles are requested to forward their current VC status. If Vigilance cleared then the details documents showing the reason for not having vigilance clearance at the time of DPC may be submitted to review the sealed cover case.

In view of above, respective Circle Heads are requested to arrange to furnish the inputs positively by 14.06.2013 as directed by the DPC to assess these left out JTOs for promotion to SDE(T) grade. This may be given top priority please.


