Kindly refer your above cited letter wherein you have sought approval of competent authority for incorporating changes in clauses -2,10 B, 10 C, 25 and additional conditions(two numbers) of General Contract Conditions(GCC i.e. BSNL W-8) in conformity to MOU signed with KVS.

Approval of the competent authority is hereby conveyed for above cited modifications. The Existing Provisions versus Modified Provisions of these Clauses are attached as Annexure-A.

It may kindly be noted that a central MOU with KVS has been signed and subsequently 2(two) Nos. of project at Jharkhand and Kerala has been allotted. In view of penalty provisions for delay, close co-ordination among Civil/Electrical/Architectural Wings and strict monitoring is essential to mitigate any loss while executing the work. Following additional guidelines/instructions for KVS projects is hereby issued for compliance:

- 1. Consequent upon signing of central MOU with KVS Coordinating Officer i.e. CE(C)EP, New Delhi shall submit Project Viability Report(PVR) for each allotted work duly vetted by respective Zonal CE(C)/IFA to CE within seven days of framing of PE for the allotted work. In case allotted work (s) is/are within the Delegated Financial Power of respective Zonal CE, they shall submit PVR duly approved by them through Coordinating Officer for this office record. In case allotted works are beyond their Delegated Financial Power, draft PVR shall be submitted to CO through Coordinating Officer for information of competent authority and record.
- 2. Time Schedule for each allotted work shall be observed as per time schedule given in A/A&E/S by the client as per S.No.19 of MOU. In framing of PE and the Time Schedule is required to be projected as per CPWD procedure/norms, correct and sufficient time period shall therefore be indicated for each specific activities applicable to each allotted work for pre-construction and construction stage as per para 2.7 and Appendix-17 for Contract Period for Building Works of CPWD works Manual 2012.
- 3. It is the responsibility of the Project- in- Charge and the nodal officers of the respective wings to ensure that the work is carried out in close coordination as per the PERT chart for each project.
- 4. Any delay entailing payment of penalty to be borne by BSNL will have to be fixed on the officers responsible
